

American Geophysical Union Single-Site Sales Agreement and License

This Sales Agreement is entered into this _____ (day) of _____ (month) 201_, between the American Geophysical Union (hereinafter AGU) and _____ (hereinafter Licensee).

1. Agreement

This Sales Agreement between the AGU and the Licensee grants the Licensee a non-exclusive and nontransferable License to access **AGU Products** selected in Attachment A, according to the terms and conditions set forth in this Agreement, including all attachments and terms and conditions of use.

2. Fees

a. See Attachment C for a schedule of fees for the initial term.

3. Provisions of AGU electronic journal collection:

a. Attachment B. Licensee shall supply the complete name and address of its location and its AGU account numbers (if available).

b. License Administrator: Licensee agrees to designate a single person to be the administrator of this Agreement. The name, address, phone number, and e-mail address of the License administrator shall be listed in Attachment B. Licensee shall notify AGU of any changes to the assigned administrator or contact information.

4. Agreement Definition, Duration and Payment

a. Term: The initial term of this Agreement shall be until December 31, 2012. This Agreement shall then automatically renew for one-year terms unless otherwise terminated as provided for herein.

b. Payment: The Licensee agrees to pay AGU the appropriate License fee specified on the invoice for a term of one calendar year starting on January 1 of the current year and ending December 31. Upon receipt of a completed, signed Sales Agreement, access to the **AGU Products** will be activated. All License fees shall be paid within 30 days of invoicing for service.

c. Renewals: At the end of a calendar year, if renewal payment for the **AGU Products** is not received within 30 days after the end of the calendar year, access to the **AGU Products** will be discontinued. AGU reserves the right to modify the terms of this Agreement for any renewal period or to adjust the License fee or pricing model for any renewal period upon sixty days prior notice.

d. Usage Reports: AGU agrees to provide the Licensee COUNTER-compliant usage reports on a monthly basis for applicable **AGU Products** subscribed to by the Licensee.

5. Termination

a. Termination for Default: If either party breaches a term of this Agreement, the other may send written notice of the breach, including a reasonable cure period of not less than seven (7) business days. If the breach is not cured within that time, or if the parties do not reach a satisfactory agreement on extending the cure period, then the non-breaching party may terminate this Agreement effective immediately upon written notice. In the event of such a termination due to Default by the Licensee, the Licensee shall not receive a pro-rated refund of the unused License Fee, and shall not receive any access to the **AGU Products**. In the event of such a termination due to Default by AGU, the Licensee may be entitled to receive a pro-rated refund of the unused License Fee.

b. Termination for Convenience: Either Party may cancel this Agreement at any time by providing the other party with sixty (60) days prior written notice. In the event of such a termination by the Licensee, the Licensee shall not receive a pro-rated refund of the unused License Fee, but shall continue to receive access to the **AGU Products** through the duration of the subscription period, and in the event of such a termination by AGU, the Licensee shall be entitled to receive a pro-rated refund of the unused License Fee.

c. Access Rights for Cancelled Subscribers to AGU Electronic Editions: Except for termination for cause, upon request at time of cancellation, Licensees will be provided access to the content from **AGU Electronic Editions** for their Subscription Period through the Portico post-cancellation access program. Access is available only for those years and titles to which Licensee subscribed and subject to the terms and conditions of the Portico agreement. For example, a subscriber in 2011 would be entitled to perpetual access to 2011 content, but not content from 1996 to 2010, unless additional fees are paid to AGU upon termination.

6. General

This Agreement sets forth the entire understanding of the parties and may not be modified without the express written consent of both parties. Delivery of the **AGU Products** is in the District of Columbia, USA. The validity, construction and performance of this Agreement shall be governed by and construed in accordance with the laws of the District of Columbia, USA. The Licensee must pay any taxes lawfully due from it, other than taxes on AGU's net income, arising out of the Licensee's use of the **AGU Products** and/or the rights granted under this Agreement. The Licensee may not assign or transfer its rights under this Agreement without the express written consent of the AGU.

7. Acceptance

Signing this license constitutes acceptance by the licensee of all contents contained herein, including the attached document stipulating the Terms and Conditions under the license. Licensee warrants that they have read and understand the Terms and Conditions. Any use of AGU Publications content after such posting shall constitute acceptance of the Terms and Conditions as modified.
